

Pre-Employment Drug Test

All new hires must schedule and complete a drug screening within 2 business days.

Local Candidates: Please call the number listed at the location where you will be working to schedule and complete your screening as soon as possible. If your work location is not convenient, you may choose any site.

Out-of-State Candidates: The Corporate Occupational Health office will contact you to schedule your drug screening. You will also need to call your work location to schedule a health screening.

Bring the following documents to your appointment:

- A copy of your immunization record (including flu vaccine, if already received this year)
- Government-issued photo ID
- Work release (if you have sustained a worker's compensation injury in the past)

Please do not bring any children, food or drink with you to this appointment. Once you are checked-in for your drug screening, you will not be allowed to leave and return to the office. Please expect the appointment to take approximately 45 minutes.
